Membership Types

Adult – an adult 18 years of age or older with no dependents.

Family – a “Head of Household,” their spouse/significant other and dependent children living at home up to age 21. *Children between 18 and 21 must file for a separate membership unless actively engaged in formal studies.*

Senior – an adult 65 years of age or older, their spouse/significant other and dependent children living at home up to age 21. *Children between 18 and 21 must file for a separate membership unless actively engaged in formal studies.*

Sponsored Youth – a youth who has not reached 18 years of age and who is a dependent of, or sponsored by, an adult. Sponsors accept full responsibility for the youth on the Range and at Club activities.

Dues

Memberships run from January through December, with dues prorated quarterly. Because the Range relies on the efforts of its members to remain viable, they are expected to assist with its maintenance. Participation in Workdays and events is rewarded with discounts of up to 50% on the following year’s dues.

2. That the use of archery equipment by the participant or others on these premises or otherwise are inherently dangerous and high-risk activities, whether such equipment is discharged by the participant or others; and,

3. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and I assume full responsibility for my participation; and,

4. I willingly agree to comply with the stated and customary terms and conditions for participation. If however, I observe any unusual, significant hazard during my presence or participation, I will remove myself from participating and bring such to the immediate attention of the nearest Club official; and,

5. I, for myself and on behalf of my heirs, assignees, personal representatives and next of kin, RELEASE AND HOLD HARMLESS EDHB and El Dorado Hills Community Services District, their officers, directors, officials, agents, employees, volunteers, members, guests and participants; and lessors of personal property used to conduct the events and activities, WITH RESPECT TO ANY/ALL INJURY, DISABILITY, DEATH OR LOSS OR DAMAGE TO PERSONS OR PROPERTY, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, TO THE FULL EXTENT PERMITTED BY LAW.
